What Happened

During an exceptionally rainy spring, the Tulsa area faced an unprecedented flood crisis. A combination of heavy snowmelt from the Colorado Rockies and continuous rainfall in Oklahoma caused the Arkansas River to overflow, resulting in widespread flooding. The situation worsened when the U.S. Army Corps of Engineers released water from upstream dams, exacerbating the flooding downstream. This led to emergency flood warnings and evacuation orders in communities along the river, including Tulsa.

One of the hardest-hit establishments was a prominent casino and resort, where floodwaters submerged the ground floor and parking areas. This forced an immediate closure of the property to ensure the safety of guests and staff. Popular amenities such as the pool, tiki bar, and spa—located on the ground floor—were among the facilities affected by the flooding.

Additionally, the basement, the heartbeat of the casino's operations, suffered significant damage. This space was crucial as it contained staff lockers, housekeeping services, and was where daily money transactions took place. The destruction of these essential areas added to the urgency of the restoration efforts.

Challenges and Objectives

In the aftermath of the catastrophic flooding, the casino faced immediate challenges in ensuring the safety of its patrons and staff while mitigating the extensive damage caused by the floodwaters. The ground floor, extensively affected by the flooding, required urgent restoration to resume operations swiftly. Moreover, as one of the largest employers in the area, the closure of the property posed a threat to the continuity of the resort's payroll for its employees.

With an upcoming MMA event scheduled in the casino's auditorium, the urgency to reopen in two weeks' time for the high-profile occasion became a pressing objective. Meeting this deadline was critical not only for the casino's operational continuity but also for maintaining its reputation as a premier entertainment venue in the region.
